# Committees Member Needed for Northwest Elementary Schools Boundary Process

*Volunteers asked to express interest by July 08.*

Baltimore County Public Schools planners are seeking parents and staff volunteers from each of the 10 schools included in the upcoming Northwest Elementary School Boundary Process to serve on the project's study committee.

Two BCPS parents and one staff committee member per school are needed to represent Campfield Early Learning Center and Church Lane, Deer Park, Hernwood, Lyons Mill, New Town, Randallstown, Scotts Branch, Winand, and Woodholme elementary schools.

The purpose of the study is to expand attendance areas for two new replacement buildings for Deer Park and Scotts Branch elementary schools, to relieve enrolment pressures at northwest area

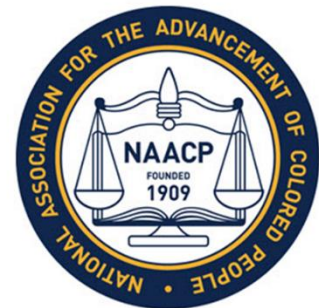
elementary schools, and to facilitate the move of students currently attending Campfield Early Learning Center to attend their home school or regional program.

Community members interested in serving on the committee are encouraged to express interest by Monday, July 8. Those interested in participating on the boundary study committee should complete the [Committee Member Interest Form](#) or contact their school's principal.

Boundary study committee members will be selected this summer and will convene in September 2024. Between September and December, the group will meet seven times, including the hosting of a public information session. In February and March of 2025, the Board of Education of Baltimore County is scheduled

to receive a committee recommendation, hold a public hearing, and take action on the recommendation.

BCPS provides many ways to stay informed and to advocate for specific concerns as part of the overall process.
